1 Welcome

The Chair and Deputy Chair opened and welcomed everyone to the AGM meeting.

2 Key Note Speaker

Ramil Adhikari welcomed the two guest speakers.

- Amitha Krishnamurthi Refugee Resettlement Manager. Refugee Quota Programme, Refugee and Migrant Services | Immigration New Zealand, Immigration New Zealand Te Āhuru Mōwai o Aotearoa. Ministry of Business Innovation & Employment
- Kabba Bah Resettlement Case Officer at Te Āhuru Mōwai o Aotearoa | Immigration New Zealand Te Āhuru Mōwai o Aotearoa. Ministry of Business Innovation & Employment

The speakers spoke on the topic The Refugee Journey to Aotearoa New Zealand shared;

- The process undertaken in conjunction UNHCR, the UN Refugee Agency to bring refugees to New Zealand.
- Who and which countries refugees are coming through into New Zealand.
- That New Zealand has seven intakes during a year where it brings in 1,500.
- The role the Mangere Refugee Resettlement Centre and what it provides as apart of the resettlement journey.
- Insight into the personal experience of the process and now being apart of providing that for others.

4 Chair's Report

Vanessa thanked everyone for coming and to Ramil for organising the speaker. The Board members were asked to introduce themselves as there are a number of new faces from 2023.

Vanessa thanked the staff, volunteers, board members, funders and supporting agencies for the contribution they make to making KiwiClass a warm place for students/clients.

Vanessa highlighted the following areas of her report and the 2023 year.

- We have been able to begin the process of rebuilding post covid and this has included new furniture and laptops.
- The positive EER review that has given us acclamation of the value we provide for students and the community.

Vanessa also noted that we need to review our Constitution so that we could maintain our charitable status. The reviewed Constitution would be presented at the AGM in 2025.

5 Treasurer's Report and audited financial statement

Nic Quill presented the 2023 financial report on behalf of the Board and shared the following;

- The financial story of KiwiClass as an analogy of his wife's recent ultra marathon.
 - The start running up hill, one foot at a time being very carful and not looking to far ahead. Financially the path ahead for KiwiClass in 2021 was uncertain and unknown.
 - The path becoming flatter but a night so while the ground was more stable it was at night therefore still required care. The financial path was becoming more stable but had to take a very disciplined approach.
 - The running path became flatter and financially we had a good footing but had to ensure that we maintained strong discipline.
 - We are currently in a place where the footing is good and can begin to look forwards through investing in people, systems, and resources, whilst being conservative.
- We received an unqualified audit report, which means there were no large or impactful errors in the Financial Statements
- Shared the financial Performance and position of KiwiClass as being positive and where we have reduced our liabilities and managed to return to having a healthy reserve.
- Need to be mindful that covid does still have an impact on us, as may the coalition Government, and high inflation which will increase our costs up.
- In a position where we can invest in people
- As Teachers the focus needs to remain on delivery of quality services.

Question from the floor – how have we managed to reduce the liabilities? Through increasing delivery and decreasing expenses.
